

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Education Child Care Services Program
Child Care and Development Fund Mandatory Carry Forward Budget)**

RESOLUTION NO. 21-232

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Grants and Contracts Office has identified
8 Department of Education Child Care and Development Fund Mandatory Carry
9 Forward funds in the amount of \$130,025.84; and

10 **WHEREAS,** the Department of Education Child Care Services Program has prepared and
11 submitted for review and approval its FY 2021 Child Care and Development Fund
12 Child Care and Development Fund Mandatory Carry Forward Budget, which is
13 incorporated by this reference, in the amount of \$130,025.84; and

14 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
15 reviewed the FY 2021 Department of Education Child Care Services Program Child
16 Care and Development Fund Mandatory Carry Forward Budget and recommend
17 its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2021 Department of Education Child Care Services Program Child Care and
20 Development Fund Mandatory Carry Forward Budget effective October 1 2020, in
21 the amount of \$130,025.84, which shall be funded from the Nation's general fund
22 pending reimbursement from the grantor, the U.S. Department of Health and
23 Human Services, Administration for Children and Families.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2021 Department of Education Child Care Services Program Child
27 Care and Development Fund Mandatory Carry Forward Budget, provided that any
28 amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.


