

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Education Child Care Services Program
Child Care and Development Fund CARES Act Carry Forward Budget)**

RESOLUTION NO. 21-234

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation ... and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2021 Child Care and Development Fund CARES Act Carry Forward**
9 **Budget, which is incorporated by this reference, in the amount of \$1,088,065.15 to**
10 **be funded from the Nation's general fund pending reimbursement from the**
11 **grantor, the U.S. Department of Health and Human Services, Administration for**
12 **Children and Families; and**

13 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
14 **reviewed the FY 2021 Department of Education Child Care Services Program Child**
15 **Care and Development Fund CARES Act Carry Forward Budget and recommend**
16 **its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2021 Department of Education Child Care Services Program Child Care and**
19 **Development Fund CARES Act Carry Forward Budget effective October 1, 2020 in**
20 **the amount of \$1,088,065.15, which shall be funded from the Nation's general**
21 **fund pending reimbursement from the grantor, the U.S. Department of Health**
22 **and Human Services, Administration for Children and Families.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2021 Department of Education Child Care Services Program Child**
26 **Care and Development Fund CARES Act Carry Forward Budget, provided that any**
27 **amendments or modifications shall be submitted for prior approval by the**
28 **Tohono O'odham Legislative Council.**
