

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Chukut Kuk District San Miguel Community and Williams
Ranch Community Budget Amendments No. 1 and FY 2021 Chukut
Kuk District Budget Amendment No. 2)**

RESOLUTION NO. 21-239

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council

11 ; and

12 **WHEREAS,** the FY 2021 Chukut Kuk District Budget in the amount of \$2,369,762.78 was
13 authorized by Chukut Kuk District Council Resolution No. 2020-24 and approved
14 by Legislative Council Resolution No. 20-316, and subsequently amended by
15 Chukut Kuk District Council Resolution No. 2020-36 and approved by Legislative
16 Council Resolution No. 21-007 in the amount of \$2,401,213.16; and

17 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2021-22, the Chukut Kuk District
18 has authorized and submitted for review and approval its FY 2021 San Miguel
19 Community Budget Amendment No. 1, FY 2021 Williams Ranch Community
20 Budget Amendment No. 1, and FY 2021 Chukut Kuk District Budget Amendment
21 No. 2, which are incorporated by these references and which will adjust
22 operational and/or personnel line items; and

23 **WHEREAS,** the FY 2021 Chukut Kuk District San Miguel Community Budget Amendment No.
24 1 will increase the FY 2021 San Miguel Community Budget by \$26,269.35 from
25 \$40,000.00 to \$66,269.35 and the FY 2021 Chukut Kuk District Williams Ranch
26 Community Budget Amendment No. 1 will increase the FY 2021 Williams Ranch
27 Community Budget by \$45,201.20 from \$20,000.00 to \$65,201.20; and

28 **WHEREAS,** the FY 2021 Chukut Kuk District Budget Amendment No. 2 will incorporate the FY
29 2021 San Miguel Community and Williams Ranch Community Budget
30 Amendments No. 1 and will increase the FY 2021 Chukut Kuk District Budget by
31 \$71,470.55 from \$2,401,213.16 to \$2,472,683.71; and

1 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Chukut Kuk District**

3 **1 and the FY 2021 Chukut Kuk District Budget Amendment No. 2 and recommend**
4 **their approval.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:**

- 6 (1) **FY 2021 Chukut Kuk District San Miguel Community Budget Amendment**
7 **No. 1 effective October 1, 2020, which includes a \$26,269.35 increase from**
8 **\$40,000.00 to \$66,269.35 that shall be funded by FY 2020 carryover funds;**
9 (2) **FY 2021 Chukut Kuk District Williams Ranch Community Budget**
10 **Amendment No. 1 effective October 1, 2020, which includes a \$45,201.20**
11 **increase from \$20,000.00 to \$65,201.20 that shall be funded as follows:**
12 • **FY 2020 Carryover in the amount of \$18,999.40**
13 • **FY 2016 Carryover in the amount of \$13,776.79**
14 • **FY 2014 Mining in the amount of \$5,891.29**
15 • **FY 2016 Mining in the amount of \$6,533.72; and**
16 (3) **FY 2021 Chukut Kuk District Budget Amendment No. 2, which incorporates**
17 **the FY 2021 San Miguel Community and Williams Ranch Community**
18 **Budget Amendments No. 1 and which will increase the FY 2021 Chukut Kuk**
19 **District Budget by \$71,470.55 from \$2,401,213.16 to \$2,472,683.71.**


20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Chukut**
21 **Kuk District Budget as amended shall be managed and expended in accordance**
22 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
23 **the Nation's laws, provided that any amendments or modifications shall be**
24 **authorized under District Council resolution and submitted for prior approval by**
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
27 **day of JULY, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
