

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Department of Health and Human Services Division of Senior  
Services Arizona Long Term Care System Budget Amendment No. 1)**

**RESOLUTION NO. 21-244**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Health and Human Services Division of Senior Services**  
8 **Arizona Long Term Care System ("ALTCS") Budget in the amount of \$615,241.00**  
9 **was approved by Resolution No. 20-280; and**

10 **WHEREAS, the Department of Health and Human Services Division of Senior Services has**  
11 **prepared and submitted for review and approval its FY 2021 ALTCS Budget**  
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**  
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2021 Department of Health and Human Services Division of Senior Services**  
15 **ALTCS Budget Amendment No. 1 will decrease the budget by \$18,541.50 from**  
16 **\$615,241.00 to \$596,699.50; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
18 **reviewed the FY 2021 Department of Health and Human Services Division of**  
19 **Senior Services ALTCS Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2021 Department of Health and Human Services Division of Senior Services**  
22 **ALTCS Budget Amendment No. 1 effective October 1, 2020, which includes a**  
23 **\$18,541.50 decrease from \$615,241.00 to \$596,699.50.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2021 Department of Health and Human Services Division of Senior**  
27 **Services ALTCS Budget as amended, provided that any amendments or**  
28 **modifications shall be submitted for prior approval by the Tohono O'odham**  
29 **Legislative Council.**


