2		this reference and which will adjust operational and/or personnel line items; and
3	WHEREAS,	the FY 2021 Water Resources Department EPA Budget Amendment No. 1 will
4		increase the FY 2021 EPA Budget by \$58,961.64 from \$135,000.00 to \$193,961.64;

6	WHEREAS,	the Water Resources and Budget and Finance Committees have reviewed the FY
7		2021 Water Resources Department EPA Budget Amendment No. 1 and
8		recommend its approval.
9	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		FY 2021 Water Resources Department EPA Budget Amendment No. 1 effective
21		October 1, 2020, which includes a \$58,961.64 increase from \$135,000.00 to
22		\$193,961.64 that shall be funded by FY 2020 Water Resources Department EPA
23		Budget carry-forward funds.
