

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Tohono O'odham Nation Health Care CARES Act Budget Amendments)**

RESOLUTION NO. 21-253

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") Governing Body was**
8 **delegated the authority to review and approve all TONHC budgets and budgets**
9 **expending health self-governance funds, including budgets expending such**
10 **funds for supporting programs within other Nation's departments, subject to**
11 **Legislative Council oversight committee review and final approval by Legislative**
12 **Council resolution (Tohono O'odham Nation Health Care Governing Body Bylaws,**
13 **Section 9403 (A)); and**

14 **WHEREAS, the FY 2020 Tohono O'odham Nation Health Care CARES Act Budgets in the**
15 **amount of \$3,519,205.00 was approved by Resolution No. 20-335 effective March**
16 **1, 2020 to September 30, 2021; and**

17 **WHEREAS, the Nation's financial management software automatically changed the title of**
18 **the FY 2020 Tohono O'odham Nation Health Care CARES Act Budgets to FY 2021**
19 **Tohono O'odham Nation Health Care CARES Act Budgets because the budgets end**
20 **in fiscal year 2021; and**

21 **WHEREAS, the Tohono O'odham Nation Health Care has prepared and submitted for review**
22 **and approval the FY 2021 Tohono O'odham Nation Health Care CARES Act Budget**
23 **Amendments, which are incorporated by these references and which will adjust**
24 **operational and/or personnel line items, and which are identified in the July 2021**
25 **Table below:**

1 **WHEREAS, the FY 2021 TONHC CARES Act Budget Amendments will not change the budget**
2 **amount of \$3,519,205.00; and**


3 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
4 **reviewed the FY 2021 TONHC CARES Act Budget Amendments and recommend**
5 **their approval.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
7 **FY 2021 Tohono O'odham Nation Health Care CARES Act Budget Amendments**
8 **effective March 1, 2020 through September 30, 2021 and which will not change the**
9 **original budget amount of \$3,519,205.00.**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
11 **Nation chairperson or any designated official is authorized to administer and**
12 **expend the FY 2021 Tohono O'odham Nation Health Care CARES Act Budgets as**
13 **amended, provided that any amendments or modifications shall be submitted**
14 **for prior approval by the Tohono O'odham Legislative Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
16 **day of JULY, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
18 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
19 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat.984).**
