

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amended and Restated Joint Development Agreement)**

RESOLUTION NO. 21-255

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to promote, protect and provide for . . . general welfare of the Tohono**
3 **O'odham Nation and its members" (Constitution, Article VI, Section 1(c)(2)); and**


4 **WHEREAS, the Legislative Council has by Resolution No. 19-465 approved an agreement, as**
5 **amended by Resolution No. 20-102 and Resolution No. 20-173 and gave final**
6 **approval by Resolution No. 20-206 for a proposal to benefit the Nation and its**
7 **members; and**

8 **WHEREAS, the Commerce and Agricultural and Natural Resource Committees have reviewed**
9 **amendments to a related agreement previously approved by the Legislative**
10 **Council and recommend that it be approved.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **Amended and Restated Joint Development Agreement in the form presented to**
13 **the Legislative Council in closed session on July 15, 2021 and authorizes the**
14 **Nation's chairperson to sign it.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
16 **day of JULY, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
18 **Article VI, Section 1(c)(2) and Section 1(j) of the Constitution of the Tohono O'odham Nation,**
19 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
20 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
21 **Act of June 18, 1934 (48 Stat.984).**


