14		membership and adoption applications misspelled or incorrectly listed the
15		names of members; and
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 41-82, 184-83, 150-84,
17		142-89, 308-89, 03-536, 04-109, 05-301, 06-059, and 06-328 be amended to reflect
18		the correct names for the members identified in the August 2021 Corrected
19		Enrollment Resolution Summary, which is incorporated by this reference.
