

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Membership Services Election Board
Budget Amendment No. 2)**

RESOLUTION NO. 21-265

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Membership Services Election Board Budget in the**
8 **amount of \$362,611.65 was approved by Resolution No. 20-282, and subsequently**
9 **amended by Resolution No. 21-133 with no change to the budget amount; and**

10 **WHEREAS, the Department of Membership Services has prepared and submitted for review**
11 **and approval its FY 2021 Election Board Budget Amendment No. 2, which is**
12 **incorporated by this reference and which will adjust operational and/or**
13 **personnel line items; and**

14 **WHEREAS, the FY 2021 Department of Membership Services Election Board Budget**
15 **Amendment No. 2 will not change the budget amount of \$362,611.65; and**

16 **WHEREAS, the Rules and Budget and Finance Committees have reviewed the FY 2021**
17 **Department of Membership Services Election Board Budget Amendment No. 2**
18 **and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2021 Department of Membership Services Election Board Budget Amendment**
21 **No. 2 effective October 1, 2020, which does not change the budget amount of**
22 **\$362,611.65.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2021 Department of Membership Services Election Board Budget**
26 **as amended, provided that any amendments or modifications shall be submitted**
27 **for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
29 **day of AUGUST, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
