

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Request for the Transfer of August 2020 Chukut Kuk District
Remaining Gaming Allocation)**

RESOLUTION NO. 21-267

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that [a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
8 Nation,

9 No district council shall expend district funds except pursuant to budgets
10 authorized under resolutions of the district council and approved by the
11 Tohono O'odham Council. The management of these funds shall be only by
12 a treasurer or other authorized officer of the district council who has
13 furnished a surety bond satisfactory to the treasurer of the Tohono
14 O'odham Nation, and all expenditures of these funds shall be by checks
15 signed by such treasurer or other authorized officer and the chairman or
16 vice chairman of the district council.

18 **WHEREAS,** the FY 2021 Chukut Kuk District Administration and Community Budgets in the
19 amount of \$2,369,762.78 was authorized by Chukut Kuk District Council
20 Resolution No. 2020-24 and approved by Legislative Council Resolution No. 20-
21 316; and

22 **WHEREAS,** the FY 2021 Chukut Kuk District Administration and Community Budgets was
23 funded in part by the August 2020 District Allocation in the amount of
24 \$2,283,613.89 and in part by carryover funds in the amount of \$86,148.89; and

25 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2021-23, the Chukut Kuk District
26 has authorized and submitted for review and approval its request to transfer the
27 remaining balance of the August 2020 Chukut Kuk District Gaming Allocation in
28 the amount of \$790,429.97 to the Chukut Kuk District investment account; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed the request from the Chukut
30 Kuk District to transfer its remaining August 2020 Chukut Kuk District Gaming
31 Allocation and recommends its approval.




1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
2 **transfer of the remaining August 2020 Chukut Kuk District Gaming Allocation in**
3 **the amount of \$790,429.97 to the Chukut Kuk District investment account,**
4 **provided that any expenditure of these funds shall be subject to a budget**
5 **authorized by the Chukut Kuk District Council and approved by Legislative**
6 **Council resolution.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
8 **day of AUGUST, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
10 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
11 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
12 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
13 **(48 Stat.984).**
