The management of these funds shall be only by 5 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and the FY 2021 Gu Achi District COVID-19 Pandemic Budget in the amount of 12 WHEREAS. \$334,848.00 was authorized by the Gu Achi District Council Resolution No. 0920-13 14 131 and approved by Legislative Council Resolution No. 20-330; and 15 by the Gu Achi District Council Resolution No. 0821-037, the Gu Achi District has WHEREAS, 16 authorized and submitted for review and approval its FY 2021 Gu Achi District 17 COVID-19 Pandemic Budget Amendment No. 1, which is incorporated by this reference and which will adjust operational and/or personnel line items; and 18 WHEREAS, 19 the FY 2021 Gu Achi District COVID-19 Pandemic Budget Amendment No. 1 will 20 not change the original budget amount of \$334,848.00; and 21 the Budget and Finance Committee has reviewed the FY 2021 Gu Achi District WHEREAS. 22 COVID-19 Pandemic Budget Amendment No. 1 and recommends its approval. NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 23 24 FY 2021 Gu Achi District Budget COVID-19 Pandemic Budget Amendment No. 1, 25 which will not change the original budget amount of \$334,848.00. 26 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Gu Achi 27 District COVID-19 Pandemic Budget Amendment as amended shall be managed 28 and expended in accordance with Article IX, Section 7 of the Constitution of the 29 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 30 modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council. 31 32 33
