RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving August 2021 District Allocation and Apportionment of Gaming Revenues to Districts by Equal Distribution)

RESOLUTION NO. 21-283

1	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds				
2		within the exclusive control of the Tohono O'odham Nation \dots and to appropriate				
3		these funds for the benefit of the nation and its members" provided that "[a]ll				
4		expenditures of these funds shall be pursuant to appropriations or budgets"				
5		authorized by resolution or ordinance" (Constitution of the Tohono O'odham				
6		Nation, Article VI, Section 1(d)(2)); and				
7	WHEREAS,	by 26 Tohono O'odham Code Chapter 1, Section 1301, the Legislative Council has				
8		adopted a formula for distributing the Nation's gaming revenues ("Formula"),				
9		which includes an allocation to the Nation's districts ("District Allocation"); and				
10	WHEREAS,	26 Tohono O'odham Code Chapter 1, Section 1304 provides that on August 1 each				
11		year the District Allocation for each district shall be apportioned in accordance				
12		with the allocation formula established by the Legislative Council; and				
13	WHEREAS,	26 Tohono O'odham Code Chapter 1, Section 1301(B)(2)(a) of the Formula provides				
14		that "Fifteen percent (15%) of the District Allocation shall be allocated to the				
15		District where the Gaming Facility which generated such revenue is located" (the				
16		"Host District Share"); and				
17	WHEREAS,	26 Tohono O'odham Code Chapter 1, Section 1301(B)(2)(b) and Section1304				
18		provide that the remainder of the District Allocation be divided among all eleven				
19		districts of the Nation in accordance with the allocation formula established by				
20		the Legislative Council; and				
21	WHEREAS,	the remainder of the District Allocation has historically been allocated: (1) by				
22		equal distribution, (2) by population distribution, or (3) by $50/50$ distribution ($1/2$				
23		equal and 1/2 population); and				
24	WHEREAS,	the Tohono O'odham Nation Office of the Treasurer has calculated the August				
25		2021 District Allocation in accordance with the August 2021 District Gaming				
26		Allocation Table, which is incorporated by this reference; and				
27	WHEREAS,	the Budget and Finance Committee has reviewed the August 2021 District Gaming				
28		Allocation Table.				
29	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the					
30		August 2021 Host District Share and approves the allocation of the remainder of				
31		the August 2021 District Allocation among the 11 Districts of the Nation by equal
