

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2021 Department of Health and Human Services Division of  
Child Welfare Building Budget)**

**RESOLUTION NO. 21-284**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Constitution of the Tohono O'odham Nation also vests the Legislative Council**  
8 **with the authority to "consult, negotiate and conclude agreements and contracts**  
9 **on behalf of the Tohono O'odham Nation with Federal, State and local**  
10 **governments and other Indian tribes or their departments, agencies, or political**  
11 **subdivisions, or with private persons or organizations on all matters within the**  
12 **authority of the Tohono O'odham Council" (Constitution, Article VI, Section 1(f));**  
13 **and**

14 **WHEREAS, the Legislative Council approved Resolution No. 18-403, "Approving Contract**  
15 **between Belfor Property Restoration and the Tohono O'odham Nation and**  
16 **Approving FY 2019 Department of Health and Human Services Division of Child**  
17 **Welfare Building Budget"; and**

18 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
19 **review and approval its FY 2021 Division of Child Welfare Building Budget, which**  
20 **is incorporated by this reference in the amount of \$48,028.14 to be funded from**  
21 **the Nation's general fund surplus; and**

22 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
23 **reviewed the FY 2021 Department of Health and Human Services Division of Child**  
24 **Welfare Building Budget and recommend approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
26 **FY 2021 Department of Health and Human Services Division of Child Welfare**  
27 **Building Budget, effective October 1, 2020 in the amount of \$48,028.14, which**  
28 **shall be funded by the Nation's general fund surplus.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
30 **Nation chairperson or any designated official is authorized to administer and**  
31 **expend the FY 2021 Department of Health and Human Services Division of Child**


