4		and other Indian tribes or their departments, agencies, or political subdivisions,
5		or with private persons or organizations on all matters within the authority of the
6		Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and
7	WHEREAS,	the  Nation's  General  Support  Services  has  prepared  and  submitted  for  review  and  submitted  for  review
8		approval the Arizona State Purchasing Cooperative Agreement between the State
9		of Arizona Procurement Office and the Tohono O'odham Nation ("Agreement");

11	WHEREAS,	the Agreement will allow the Tohono O'odham Nation to purchase materials and
12		services from State contractors at the prices and terms expressed in contracts
13		between the State and those State's contractors; and
14	WHEREAS,	the Agreement shall not be construed to cede any jurisdiction of either party or to
15		waive either party's sovereign immunity in any forum or jurisdiction; and
16	WHEREAS,	the Agreement will be in effect until cancelled by either party, and
17	WHEREAS,	the Budget and Finance Committee has reviewed the Agreement and
18		recommends approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		Arizona State Purchasing Cooperative Agreement between the State of Arizona
21		Procurement Office and the Tohono O'odham Nation in substantially the form
