

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting a No Cost Extension for the Budget Term of the FY 2021 Department of Health and Human Services Division of Community Health Services Public Health Emergency Preparedness COVID-19 Budget and Approving an Extension of the Budget Term)

RESOLUTION NO. 21-290

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Community
8 Health Services State Public Health Emergency Preparedness COVID-19 Budget
9 in the amount of \$123,246.00 was approved by Resolution No. 20-215; and

10 **WHEREAS,** the Department of Health and Humans Services Division of Community Health
11 Services has received a no cost extension notice from Arizona Department of
12 Health Services to extend the Public Health Emergency Preparedness COVID-19
13 Program award from March 16, 2021 through March 15, 2022; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees reviewed
15 and recommends accepting the no cost extension for the FY 2021 Department of
16 Health and Human Services Division of Community Health Services State Public
17 Health Emergency Preparedness COVID-19 Budget and approving the extension
18 of the budget term beginning March 16, 2021 to March 15, 2022.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
20 no cost extension of the Public Health Emergency Preparedness COVID-19
21 Program award and approves the extension of the budget term of the FY 2021
22 Department of Health and Human Services Division of Community Health
23 Services State Public Health Emergency Preparedness COVID-19 Budget
24 beginning March 16, 2021 to March 15, 2022.

25 **BE IT FINALLY RESOLVED** that Tohono O'odham Legislative Council authorizes the Tohono
26 O'odham Nation chairperson or any designated official to administer and expend
27 the FY 2021 Department of Health and Human Services Division of Community
28 Health Services State Public Health Emergency Preparedness COVID-19 Budget
29 for the period of March 16, 2021 through March 15, 2022, and the Accounting
30 Department is authorized to post the unexpended balances of the budget as of
31 March 16, 2021 as a carry forward into FY 2022 beginning March 16, 2021,

8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
9 18, 1934 (48 Stat.984).
