

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2022 Tohono O'odham Nation COVID-19 Incentive General
Welfare Program Budget)**

RESOLUTION NO. 21-291

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the powers "to manage any
2 funds within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance" (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation ("Nation") received funding from the United States'
8 American Rescue Plan ("Recovery Funds") established by the American Rescue
9 Plan Act of 2021 ("ARP Act"); and

10 **WHEREAS,** the Nation has prepared and submitted for review and approval its FY 2022
11 COVID-19 Incentive General Welfare Program Budget, which is incorporated by
12 this reference, in the total amount of \$11,640,000.00 to be funded in part by the
13 Recovery Funds in the amount of \$10,438,800.00, and the remaining balance of
14 \$1,201,200.00 to be funded by the Nation's general fund surplus in the amount of
15 \$1,201,200.00; and

16 **WHEREAS,** the Rules and Budget and Finance Committees have reviewed the FY 2022 Tohono
17 O'odham Nation COVID-19 Incentive General Welfare Program Budget and
18 recommend approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2022 Tohono O'odham Nation COVID-19 Incentive General Welfare Program
21 Budget effective October 1, 2021 through September 30, 2022 in the total of
22 \$11,640,000.00, which shall be funded by Recovery Funds and the Nation's general
23 fund.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2022 Tohono O'odham Nation COVID-19 Incentive General Welfare
27 Program Budget, provided that any amendments or modifications shall be
28 submitted for prior approval by the Tohono O'odham Legislative Council.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH
30 day of AUGUST, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-
31 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
32 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
33 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
34 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
35 18, 1934 (48 Stat.984).
