

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting the Tohono O'odham Nation American Rescue Plan Act Allocation Plan)**

RESOLUTION NO. 21-292

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the authority "to promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members"**
4 **and "to manage any funds within the exclusive control of the Tohono O'odham**
5 **Nation" (Constitution, Article VI, Section 1(c)(2) and Section 1(d)(2)); and**

6 **WHEREAS the Tohono O'odham Nation (the "Nation") received American Rescue Plan Act**
7 **funds in the amount of \$234,387,746.64 from the U.S. Department of Treasury;**
8 **and**

9 **WHEREAS, in consultation with the Executive Branch Chairman and Vice Chairwoman,**
10 **Judicial Branch Chief Judge Donald Harvey, and Legislative Branch Chairman**
11 **and Vice Chairwoman, the Nation developed the Tohono O'odham Nation**
12 **American Rescue Plan Act Allocation Plan (the "Allocation Plan"), which is**
13 **incorporated by this reference; and**

14 **WHEREAS, the Plan provides allocation amounts for the Nation's three branches of**
15 **government, district governments, and the Nation's affiliated entities; and**

16 **WHEREAS, the Budget and Finance and Rules Committees reviewed the proposed Allocation**
17 **Plan and recommend approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council adopts the**
19 **Tohono O'odham Nation American Rescue Plan Act Allocation Plan, provided that**
20 **any expenditures from American Rescue Plan Act funds are subject to budgets**
21 **approved by Legislative Council resolution.**


22 **BE IT FINALLY RESOLVED that the Chairperson of the Nation is authorized to execute the Tohono**
23 **O'odham Nation American Rescue Plan Act Allocation Plan and any other**
24 **documents that are reasonably necessary to implement this resolution.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
26 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(c)(2) and Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**


