

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2022 Department of Education Vocational Rehabilitation Program Budget)**

**RESOLUTION NO. 21-302**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and  
8 approval its FY 2022 Vocational Rehabilitation Program Budget, which is  
9 incorporated by this reference, in the amount of \$450,723.00 to be funded from  
10 the Nation's general fund pending reimbursement from the grantor, the United  
11 States Department of Education; and

12 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
13 reviewed the FY 2022 Department of Education Vocational Rehabilitation  
14 Program Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2022 Department of Education Vocational Rehabilitation Program Budget  
17 effective October 1, 2021 in the amount of \$450,723.00, which shall be funded by  
18 the Nation's general fund pending reimbursement from the grantor, the United  
19 States Department of Education.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2022 Department of Education Vocational Rehabilitation Program  
23 Budget, provided that any amendments or modifications shall be submitted for  
24 prior approval by the Tohono O'odham Legislative Council.

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
26 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
27 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat.984).**
