

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Department of Education Child Care and Development Fund  
Discretionary Budget and FY 2022 Department of Education Child Care and  
Development Fund Mandatory Budget)**

**RESOLUTION NO. 21-305**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and  
8 approval its FY 2022 Child Care and Development Fund Discretionary Budget,  
9 which is incorporated by this reference, in the amount of \$2,924,076.08 and its FY  
10 2022 Department of Education Child Care and Development Fund Mandatory  
11 Budget, which is incorporated by this reference, in the amount of \$590,451.00, for  
12 a combined total amount of \$3,514,527.08 to be funded by the Nation's general  
13 fund pending reimbursement from the grantor, the United States Department of  
14 Health and Human Services; and

15 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
16 reviewed the FY 2022 Department of Education Child Care and Development Fund  
17 Discretionary Budget and the FY 2022 Department of Education Child Care and  
18 Development Fund Mandatory Budget and recommend their approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2022 Department of Education Child Care and Development Fund  
21 Discretionary Budget in the amount of \$2,924,076.08 and the FY 2022 Department  
22 of Education Child Care and Development Fund Mandatory Budget in the amount  
23 of \$590,451.00 effective October 1, 2021 for a combined total of \$3,514,527.08,  
24 which shall be funded by the Nation's general fund pending reimbursement from  
25 the grantor, the United States Department of Health and Human Services.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
27 Nation chairperson or any designated official is authorized to administer and  
28 expend the FY 2022 Department of Education Child Care and Development Fund  
29 Discretionary Budget and the FY 2022 Department of Education Child Care and  
30 Development Fund Mandatory Budget, provided that any amendments or  
31 modifications shall be submitted for prior approval by the Tohono O'odham  
32 Legislative Council.
