

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Natural Resources Cultural Affairs Tribal
Historic Preservation Office Budget)**

RESOLUTION NO. 21-308

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
8 **approval its FY 2022 Cultural Affairs Tribal Historic Preservation Office Budget,**
9 **which is incorporated by this reference, in the amount of \$105,838.00 to be**
10 **funded by the Nation's general fund pending reimbursement from the grantor,**
11 **the U.S. Department of the Interior National Park Service; and**

12 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
13 **FY 2022 Department of Natural Resources Cultural Affairs Tribal Historic**
14 **Preservation Office Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2022 Department of Natural Resources Cultural Affairs Tribal Historic**
17 **Preservation Office Budget effective October 1, 2021 in the amount of \$105,838.00,**
18 **which shall be funded by the Nation's general fund pending reimbursement from**
19 **the grantor, the U.S. Department of the Interior National Park Service.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2022 Department of Natural Resources Cultural Affairs Tribal**
23 **Historic Preservation Office Budget, provided that any amendments or**
24 **modifications shall be submitted for prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
27 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**




