

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Water Resources Department Environmental Protection
Agency Budget)**

RESOLUTION NO. 21-311

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Water Resources Department has prepared and submitted for review and**
8 **approval its FY 2022 Environmental Protection Agency ("EPA") Budget, which is**
9 **incorporated by this reference, in the amount of \$135,000.00 to be funded by the**
10 **Nation's general fund pending reimbursement from the grantor, the EPA; and**

11 **WHEREAS, the Water Resources and Budget and Finance Committees have reviewed the FY**
12 **2022 Water Resources Department EPA Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2022 Water Resources Department Environmental Protection Agency Budget**
15 **effective October 1, 2021 in the amount of \$135,000.00 which shall be funded by**
16 **the Nation's general fund pending reimbursement from grantor, the EPA.**

17 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the**
18 **Nation's chairperson or any designated official to seek reimbursement for**
19 **indirect cost expenses in the event an indirect cost rate is approved.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2022 Water Resources Department Environmental Protection**
23 **Agency Budget, provided that any amendments or modifications shall be**
24 **submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
26 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
27 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and ~~0~~ ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
