16		FY 2022 Executive Branch Tribal Budgets effective October 1, 2021 in the amount						
17		of \$92,479,155.83, which shall be funded by the Nation's general fund.

19		Nation chairperson or any designated official is authorized to administer and						
20	expend the FY 2022 Executive Branch Tribal Budgets, provided that any
