14		Technology have prepared and submitted for review and approval its FY 2022
15		Tohono O'odham Nation Health Care Budgets, for the period beginning October
16		01, 2021 and ending on September 30, 2022 (collectively, "FY 2022 Tohono
17		O'odham Nation Health Care Budgets") and as identified in the FY 2022 Tohono
18		O'odham Nation Health Care Budgets Schedule, which is attached and
19		incorporated by this reference, in the total amount of \$121,872,846.14; and
