

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Planning and Economic Development Department Roads
Program Cowlic Road Project Budget)**

RESOLUTION NO. 21-328

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation was awarded \$1,500,000 for the design and**
8 **construction of Cowlic Road, which was first authorized for expenditure by**
9 **Resolution No. 14-499; and**

10 **WHEREAS, the BIA Western Region Office awarded a no-cost extension for the design and**
11 **construction of the Cowlic Road Project, Project No. PIR 31(1), to September 30,**
12 **2023; and**

13 **WHEREAS, the Planning and Economic Development Department has prepared and**
14 **submitted for review and approval its FY 2022 Roads Program Cowlic Road**
15 **Project Budget, in the amount of \$1,128,159.32, which is incorporated by this**
16 **reference, to be funded by the Nation's general fund pending reimbursement**
17 **from the grantor, the Bureau of Indian Affairs; and**

18 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
19 **have reviewed the FY 2022 Planning and Economic Development Department**
20 **Roads Program Cowlic Road Project Budget and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2022 Planning and Economic Development Department Roads Program**
23 **Cowlic Road Project Budget in the amount of \$1,128,159.32 effective October 1,**
24 **2021 through September 30, 2023, which shall be funded by the Nation's general**
25 **fund pending reimbursement from the grantor, the Bureau of Indian Affairs.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2022 Planning and Economic Development Department Roads**
29 **Program Cowlic Road Project Budget, provided that any amendments or**
30 **modifications shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**


