1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Executive Office has submitted a request for a no-cost extension and has**
8 **received approval from the BIA Western Region Office that the a no-cost**
9 **extension will be issued for the design and construction of SXIR Consolidated No.**
10 **2 Wa:K Lane and Go:k Ka:Wulk Wog Project to September 30, 2023; and**

11 **WHEREAS, the Planning and Economic Development Department has prepared and**
12 **submitted for review and approval its FY 2022 Roads Program SXIR Consolidated**
13 **No. 2 Wa:k Lane and Go:k Ka:Wulk Wog Project Budget, which is incorporated by**
14 **this reference, in the amount of \$1,931,458.08 to be funded by the Nation's general**
15 **fund pending reimbursement by the grantor, the Bureau of Indian Affairs; and**

16 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
17 **have reviewed the FY 2022 Planning and Economic Development Department**
18 **Roads Program SXIR Consolidated No. 2 Wa:K Lane and Go:k Ka:Wulk Wog Project**
19 **Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2022 Planning and Economic Development Department Roads Program SXIR**
22 **Consolidated No. 2 Wa:K Lane and Go:k Ka:Wulk Wog Project Budget effective**
23 **October 1, 2021 through September 30, 2023 in the amount of \$1,931,458.08,**
24 **which shall be funded by the Nation's general fund pending reimbursement by**
25 **the grantor, the Bureau of Indian Affairs.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2022 Planning and Economic Development Department Roads**
29 **Program SXIR Consolidated No. 2 Wa:K Lane and Go:k Ka:Wulk Wog Project**
30 **Budget, provided that any amendments or modifications shall be submitted for**
31 **prior approval by the Tohono O'odham Legislative Council.**
