

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Enrollment or Adoption Applications for Membership in the Tohono  
O'odham Nation for September 2021)**

**RESOLUTION NO. 21-338**

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**  
2 **Tohono O'odham Legislative Council with the power to "enact laws and**  
3 **ordinances governing the enrollment and adoption of members and the**  
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation Enrollment Ordinance,**  
6 **Ordinance No. 05-81 as amended, the Enrollment Committee has reviewed and**  
7 **recommended approval of the enrollment or adoption applications for the**  
8 **individuals identified in the September 2021 Membership Applications List,**  
9 **which is incorporated by this reference; and**

10 **WHEREAS, pursuant to Article VIII, Section 1 (C) (1) and (2) of the Enrollment Ordinance:**

11 **The final determination to approve or reject an application for**  
12 **membership or adoption shall be recorded in a Council resolution. Each**  
13 **determination shall set forth the following findings of fact:**

14 **(1) If an application for adoption is approved, the applicant's date of birth,**  
15 **the degree of Papago-Tohono O'odham Indian Blood ascribed to the**  
16 **applicant, and the Enrollment Committee's recommendation that the**  
17 **application be approved or rejected;**

18 **(2) If an application for membership is approved, the applicant's date of**  
19 **birth, the membership requirement which Council determined that the**  
20 **applicant established, and the Enrollment Committee's**  
21 **recommendation that the application be approved or rejected.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**  
23 **the Enrollment Committee's recommendations and approves the applications**  
24 **for enrollment or adoption that are identified in the September 2021**  
25 **Membership Applications List which includes the name, date of birth, enrollment**  
26 **number, and membership requirement or, for adoption, the degree of Papago-**  
27 **Tohono O'odham Indian blood for each applicant.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
29 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**  
31 **Article II, Section 1(a) or (b) and Section 2 and Article VI, Section 1(h) of the Constitution of the**  
32 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**  
33 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
34 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
