

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 2000-223, 01-416, 02-180, 03-193, 03-493,
04-508, 05 204, 05-368, 07-075, 09-477, and 21-223 to Correct Names and/or
Enrollment Numbers of Enrolled Members)**

RESOLUTION NO. 21-340

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1- Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council, with the recommendations of the Enrollment
12 Committee, shall determine whether an applicant is eligible for membership or
13 adoption; and

14 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
15 membership and adoption applications misspelled or incorrectly listed the
16 names of members and/or incorrectly listed enrollment numbers; and

17 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 2000-223, 01-416,
18 02-180, 03-193, 03-493, 04-508, 05-204, 05-368, 07-075, 09-477, and 21-223 be
19 amended to reflect the correct name and/or enrollment number for the members
20 identified in the September 2021 Corrected Enrollment Resolution Summary,
21 which is incorporated by this reference.

22 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
23 Nos. 2000-223, 01-416, 02-180, 03-193, 03-493, 04-508, 05-204, 05-368, 07-075, 09-
24 477, and 21-223 are amended upon the effective date of those resolutions to
25 reflect the correct name and/or enrollment number for the members identified
26 in the September 2021 Corrected Enrollment Resolution Summary.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
28 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**
30 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
31 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
33 **16 of the Act of June 18, 1934 (48 Stat.984).**


