

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Professional Services Agreement between the Tohono O'odham Nation and Catalina Foothills School District #16)

RESOLUTION NO. 21-344

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to consult, negotiate and**
2 **conclude agreements and contracts on behalf of the Tohono O'odham Nation**
3 **with Federal, State and local governments and other Indian tribes or their**
4 **departments, agencies, or political subdivisions, or with private persons or**
5 **organizations on all matters within the authority of the Tohono O'odham**
6 **Council." (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f));**
7 **and**

8 **WHEREAS, the Department of Education Child Care Services Program wishes to enter into a**
9 **Professional Services Agreement with Catalina Foothills School District #16 to**
10 **provide child care services for the Nation's children who are eligible to receive**
11 **child care services for the period of October 1, 2020 to September 30, 2021, with**
12 **the option to renew the contract term for an additional two fiscal years; and**


13 **WHEREAS, the Human Resources Development Committee has reviewed the FY 2021**
14 **Professional Services Agreement and recommends its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2021 Professional Services Agreement between the Tohono O'odham Nation**
17 **and Catalina Foothills School District #16 in substantially the form attached.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to execute and**
20 **administer the FY 2021 Department of Education Child Care Services Program**
21 **Professional Services Agreement, provided that any amendments shall be**
22 **submitted for prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
24 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
25 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
26 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
29 **(48 Stat.984).**
