

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Institute of Museum and Library Services Native American Library Services Basic Grant and Approving FY 2022 Department of Education Institute of Museum and Library Services Native American Library Services Basic Grant Budget)**

RESOLUTION NO. 21-345

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education Venito Garcia Library has applied for and received
8 Native American Library Services Basic Grant Award No. NAB-250413-OLS-21 in
9 the amount of \$10,000.00 from the Institute of Museum and Library Services
10 ("IMLS") Native American Library Services; and

11 **WHEREAS,** the Department of Education has prepared and submitted for review and
12 approval its FY 2022 Department of Education IMLS Native American Library
13 Services Basic Grant Budget, which is incorporated by this reference, in the
14 amount of \$10,000.00; and

15 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
16 reviewed the FY 2022 Department of Education IMLS Native American Library
17 Services Basic Grant Budget and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
19 Institute of Museum and Library Services Native American Library Services Basic
20 Grant Award No. NAB-250413-OLS-21 and approves the FY 2022 Department of
21 Education Institute of Museum and Library Services Native American Library
22 Services Basic Grant Budget effective August 1, 2021 in the amount of \$10,000.00.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2022 Department of Education IMLS Native American Library
26 Services Basic Grant Budget, provided that any amendments or modifications
27 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
29 day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
30 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,
31 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
32 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
34 18, 1934 (48 Stat.984).
