

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Public Safety Environmental Protection
Office Brownfields Budget Amendment No. 1)**

RESOLUTION NO. 21-349

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Public Safety Environmental Protection Office ("EPO")**
8 **Brownfields Budget in the amount of \$137,000.00 was approved by Resolution No.**
9 **20-270; and**

10 **WHEREAS, the Department of Public Safety EPO has prepared and submitted for review and**
11 **approval its FY 2021 Brownfields Budget Amendment No. 1, which is incorporated**
12 **by this reference and which will adjust personnel and/or operational line items;**
13 **and**

14 **WHEREAS, the FY 2021 Department of Public Safety EPO Brownfields Budget Amendment No.**
15 **1 will increase the FY 2021 Department of Public Safety EPO Brownfields Budget**
16 **by \$62,659.83 from \$137,000.00 to \$199,659.83; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
18 **2021 Department of Public Safety EPO Brownfields Budget Amendment No. 1 and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2021 Department of Public Safety Environmental Protection Office**
22 **Brownfields Budget Amendment No. 1, which includes a \$62,659.83 from**
23 **\$137,000.00 to \$199,659.83 that shall be funded by the United States**
24 **Environmental Protection Agency Assistant Agreement Grant under the**
25 **Brownfields Program.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2021 Department of Public Safety Environmental Protection Office**
29 **Brownfields Budget as amended, provided that any amendments or**
30 **modifications shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**


