

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 San Lucy District Budget)**

**RESOLUTION NO. 21-370**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **WHEREAS,** by San Lucy District Council Resolution No. 09-203-21, the San Lucy District has  
12 authorized the FY 2022 San Lucy District Budget, which is incorporated by this  
13 reference, in the amount of \$18,929,001.49; and

14 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 San Lucy District  
15 Budget and recommends its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 **FY 2022 San Lucy District Budget in the amount of \$18,929,001.49 effective**

- 18 1. **August 2021 District Allocation in the amount of \$4,288,132.27;**
- 19 2. **August 2021 District Allocation host share in the amount of \$5,076,127.34;**
- 20 3. **JP Morgan account in the amount of \$1,564,741.88; and**
- 21 4. **FY 2021 carry over in the amount of \$8,000,000.00.**

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022 San Lucy  
23 **District Budget shall be managed and expended in accordance with Article IX,**  
24 **Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,**  
25 **provided that any amendments or modifications shall be authorized under**  
26 **District Council resolution and submitted for prior approval by the Tohono**  
27 **O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>**  
29 **day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**  
31 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
34 **(48 Stat.984).**
