The management of these funds shall be only by 5 a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 :and 12 WHEREAS, by Sells District Council Resolution No. SD-88-21, the Sells District has authorized 13 the FY 2022 Sells District Administration and Communities Budgets, which are 14 incorporated by these references, in the amount of \$4,288,132.28; and 15 the Budget and Finance Committee has reviewed the FY 2022 Sells District WHEREAS, 16 Administration and Communities Budgets and recommend approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2022 Sells District Administration and Communities Budgets effective October 19 1, 2021 in the amount of \$4,288,132.28, which shall be funded by the August 2021 20 **Sells District Gaming Allocation.** BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Sells 21 District Administration and Communities Budgets shall be managed and 22 23 expended in accordance with Article IX, Section 7 of the Constitution of the 24 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 25 modifications shall be authorized under District Council resolution and 26 submitted for prior approval by the Tohono O'odham Legislative Council. 27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the  $22^{ND}$ 28 day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; 29 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, 30 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -31 32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
