The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 :and 12 WHEREAS. by Sells District Council Resolution No. SD-89-21, the Sells District has authorized 13 the FY 2022 Sells District Economic Development Committee Budget, which is 14 incorporated by this reference, in the amount of \$90,260.00; and 15 WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 Sells District 16 Economic Development Committee Budget and recommends its approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2022 Sells District Economic Development Committee Budget effective 19 October 1, 2021 in the amount of \$90,260.00, which shall be funded by the Sells 20 District - Economic Development Account with Morgan Stanley Smith Barney. 21 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Sells 22 District Economic Development Committee Budget shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the 23 24 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 25 modifications shall be authorized under District Council resolution and 26 submitted for prior approval by the Tohono O'odham Legislative Council. 27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND 28 day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; 29 -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,
