

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Sif-Oidak District Gaming Revenue Budget)**

**RESOLUTION NO. 21-373**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **;and**

12 **WHEREAS, by Sif-Oidak District Council Resolution No. SODC 21-155, the Sif-Oidak District**  
13 **has authorized the FY 2022 Sif-Oidak District Gaming Revenue Budget, which is**  
14 **incorporated by this reference, in the amount of \$3,723,808.70; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 Sif-Oidak District**  
16 **Gaming Revenue Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2022 Sif-Oidak District Gaming Revenue Budget effective October 1, 2021 in the**  
19 **amount of \$3,723,808.70, which shall be funded by the August 2021 District**  
20 **Gaming Allocation.**


21 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the remaining funds**  
22 **in the amount of \$564,323.58 from the August 2021 Sif-Oidak District Gaming**  
23 **Allocation amount of \$4,288,132.28 approved by Legislative Council Resolution**  
24 **No. 21-283 shall remain with the Tohono O'odham Nation Office of the Treasury**  
25 **until a budget is formulated, provided that any expenditure of these funds shall**  
26 **be subject to a budget authorized by the Sif-Oidak District Council and approved**  
27 **by Legislative Council resolution.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Sif-Oidak**  
29 **District Gaming Revenue Budget shall be managed and expended in accordance**  
30 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**  
31 **the Nation's laws, provided that any amendments or modifications shall be**  
32 **authorized under District Council resolution and submitted for prior approval by**  
33 **the Tohono O'odham Legislative Council.**



6 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
7 **(48 Stat.984).**


