13		FY 2022 Gu-Vo District Budget, which is incorporated by this reference, in the
14		amount of \$4,288,132.28; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2022 Gu-Vo District
16		Budget and recommends its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2022 Gu-Vo District Budget in the amount of \$4,288,132.28, which shall be
19		funded by the August 2021 District Allocation.
20	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Gu-Vo
21		District Budget shall be managed and expended in accordance with Article IX,
22		Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's
23		Laws, provided that any amendments or modifications shall be authorized under
24		District Council resolution and submitted for prior approval by the Tohono
