7	WHEREAS,	the Legislative Council adopted the 2020 Non-Gaming Per Capita Plan by
8		Legislative Council Resolution No. 20-070 to govern a one-time non-gaming
9		revenue per capita distribution to Eligible Members of the Tohono O'odham
10		Nation; and
11	WHEREAS,	by Resolution No. 20-291, the Tohono O'odham Legislative Council approved the
12		Master List for the 2020 Non-Gaming Per Capita Distribution for Eligible Tohono
13		O'odham Minor Members and approved the total number of verified Eligible
14		Tohono O'odham Minor Members for the 2020 Non-Gaming Per Capita as 10,205
15		members; and
16	WHEREAS,	the Tohono O'odham Membership Services Enrollment Program has identified
17		one Minor Member who was left off the Master List for the 2020 Non-Gaming Per
18		Capita and has identified the additional Minor Member in the October 2021
19		Certification Listing of Minor Members for the Non-Gaming Per Capita
20		Distribution, which is incorporated by this reference; and
21	WHEREAS,	Tohono O'odham Membership Services has prepared and submitted to the
22		Tohono O'odham Legislative Council the addition to the Master List for Eligible
23		Tohono O'odham Minor Members for review and approval for the 2020 Non-
24		Gaming Per Capita Distribution; and
25	WHEREAS,	the disbursement of funds to each Eligible Tohono O'odham Minor Member is
26		contingent upon verification of a member's eligibility and further certification
27		by the Tohono O'odham Legislative Council; and
28	WHEREAS,	the Rules Committee has reviewed the addition to the Master List for the 2020
29		Non-Gaming Per Capita Distribution for Eligible Tohono O'odham Minor
30		Members and recommends its approval.
31	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
