

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Tohono O'odham Ki:Ki Association to Submit a 2021 Competitive
Indian Housing Block Grant Application for a 20 Unit Low-Income New
Homeownership Housing Construction Project)**

RESOLUTION NO. 21-390

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members"**
4 **(Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally**
6 **designated housing entity in accordance with the Native American Housing**
7 **Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-**
8 **330, 110 Stat. 4016 ("NAHASDA") and is authorized to receive and administer the**
9 **Indian Housing Block Grant ("IHBG") and to seek other funds to operate and**
10 **expand affordable housing; and**

11 **WHEREAS, the TOKA wishes to continue providing new affordable housing to meet the needs**
12 **of community members by submitting a 2021 Competitive IHBG application for**
13 **\$5,000,000 and to leverage these funds with Indian Housing Block Grant funds for**
14 **construction of 20 low-income new homeownership housing units to serve and**
15 **improve the quality of life for tribal community members; and**

16 **WHEREAS, the Housing Committee has reviewed the 2021 Competitive IHBG application and**
17 **recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 19 1. **the TOKA is authorized to submit the 2021 application for 2021**
20 **Competitive IHBG funding in the amount of \$5,000,000 and to leverage**
21 **these funds with Indian Housing Block Grant funds to construct 20 new**
22 **low-income homeownership housing units; and**
- 23 2. **the Nation certifies and confirms that it will assume environmental**
24 **responsibilities under 24 CFR Part 58.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs**
26 **the Nation's chairperson or any designated official to execute all documents**
27 **necessary for the TOKA to submit the 2021 Competitive IHBG application and any**
28 **documents that may require the Nation's chairperson's signature post award,**
29 **including the environmental review.**
