

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Tohono O'odham Ki:Ki Association to Submit 2021 Indian Community
Development Block Grant – American Rescue Plan Grant Applications)**

RESOLUTION NO. 21-392

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power “to promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members”**
4 **(Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association (“TOKA”) is the Nation's tribally**
6 **designated housing entity in accordance with the Native American Housing**
7 **Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-**
8 **330, 110 Stat. 4016 (“NAHASDA”) and is authorized to receive and administer the**
9 **Indian Housing Block Grant and to seek other funds to operate and expand**
10 **affordable housing and supportive facilities; and**

11 **WHEREAS, the TOKA wishes to apply for the Indian Community Development Block Grant**
12 **Imminent Threat funding provided under the American Rescue Plan Act of 2021**
13 **(“ICDBG-ARP” grants), P.L. 117-2, and will use these funds to prevent further**
14 **spread of the COVID-19 virus by providing additional emergency housing**
15 **(purchase and install container homes, develop the infrastructure and pads for**
16 **each site), making improvements to roads within housing developments, and**
17 **making infrastructure (water, sewer, power) improvements to current and**
18 **planned housing developments; and**

19 **WHEREAS, although the 2021 ICDBG-ARP Implementation Notice, PIH-2021-22, waives the**
20 **requirement for applicants to meet the Citizen Participation requirements of 24**
21 **CFR 1003.604(a)(2) and (b) and 1003.305(c)(3) prior to submission of an**
22 **application, the Nation fully intends to meet the Citizen Participation**
23 **requirements of 24 CFR 1003.604 and will submit a certification of compliance**
24 **after submission of the two separate ICDBG-ARP applications; and**

25 **WHEREAS, the Housing Committee has reviewed the ICDBG-ARP applications and**
26 **recommends approval.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the TOKA**
28 **is authorized to submit two separate applications for ICDBG-ARP Imminent**
29 **Threat funding, as follows:**

- 30 1. **ICDBG-ARP 2021 Phase II in the amount of \$3,450,000; and**
- 31 2. **ICDBG-ARP 2021 Phase III in the amount of \$3,450,000.**



1 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Nation confirms
2 it will comply with the Citizen Participation requirements of 24 CFR 1003.604.


3 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes and directs
4 the Nation's chairperson to execute all documents necessary for the TOKA to
5 submit the applications for the 2021 ICDBG-ARP for Phase II and Phase III
6 funding and any documents that may require the Nation's chairperson's
7 signature post award, including the environmental review.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH
9 day of OCTOBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
10 -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,
11 Article VI Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
12 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
14 18, 1934 (48 Stat.984).
