8	WHEREAS,	fees for services for these eleven Attorney Contracts will be paid by the FY 2022
9		Office of Attorney General Budget; and
10	WHEREAS,	the Domestic Affairs Committee has reviewed the eleven FY 2022 Attorney
11		Contracts and recommends approval.
12	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
13		1. Approves the eleven Attorney Contracts for FY 2022 for the Office of Attorney
14		General, which shall be funded by the FY 2022 Office of the Attorney General
15		Budget and shall be effective from October 1, 2021 to September 30, 2022.
16		2. Authorizes the Tohono O'odham Nation chairperson to execute the eleven
17		Attorney Contracts in substantially the form attached.
18		3. Authorizes the Chairman of the Nation or any designated official to
19		administer the eleven Attorney Contracts, provided that any amendments or
20		modifications shall be submitted for prior approval by the Tohono O'odham
