4		agreements and contracts on behalf of the Tohono O'odham Nation with Federal,					
5		State and local governments and other Indian tribes or their departments,					
6		agencies or political subdivisions, or with private persons or organizations on all					
7		matters within the authority of the Tohono O'odham Council." (Constitution of					
8		the Tohono O'odham Nation, Article VI, Section 2(a) and Section 1(f)); and					
9	WHEREAS,	the Office of Attorney General has prepared and submitted for review and					
10		approval the FY 2022 Attorney Contracts for Gaming ("Attorney Contracts"), which					
11		is incorporated by this reference; and					
12	WHEREAS,	there are three Attorney Contracts with firms, for the purposes and for the					
13		amounts indicated in attached Exhibit A; and					
14	WHEREAS,	fees for services for these three Attorney Contracts will be paid by the Tohono					
15		O'odham Gaming Enterprise ("TOGE"), pursuant to Title 16 TOC Chapter 2,					
16		Section 7(b)(6); and					
17	WHEREAS,	the Domestic Affairs and Gaming Negotiating Committees have reviewed the					
18		three FY 2022 Attorney Contracts and recommend approval.					
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:					
20		1. Approves the three Attorney Contracts for FY 2022 for the Office of Attorney					
21		General, which shall be funded by TOGE, pursuant to Title 16 TOC Chapter					
22		2, Section 7(b)(6), and shall be effective from October 1, 2021 to September					
23		30, 2022.					
24		2. Authorizes the Tohono O'odham Nation chairperson to execute the three					
25		Attorney Contracts in substantially the form attached.					
26		3. Authorizes the Chairman of the Nation or any designated official to					
27		administer the three Attorney Contracts, provided that any amendments					
28		or modifications shall be submitted for prior approval by the Tohono					
29		O'odham Nation Legislative Council.
