

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Department of Health and Human Services Division of Senior  
Services Title VI Part A and Title VI Part C Budget Amendments No. 1)**

**RESOLUTION NO. 21-402**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Department of Health and Human Services Division of Senior Services**  
8 **Title VI Part A Budget in the amount of \$186,930.00 and Title VI Part C Budget in**  
9 **the amount of \$68,680.00 were approved by Resolution No. 21-084; and**

10 **WHEREAS, the Department of Health and Human Services ("DHHS") has prepared and**  
11 **submitted for review and approval its FY 2022 DHHS Division of Senior Services**  
12 **Title VI Part A and Title VI Part C Budget Amendments No. 1, which are**  
13 **incorporated by these references and which will adjust operational and/or**  
14 **personnel line items; and**

15 **WHEREAS, the FY 2022 DHHS Division of Senior Services Title VI Part A and Title VI Part C**  
16 **Budget Amendments No. 1 will not change the FY 2022 DHHS Division of Senior**  
17 **Services Title VI Part A and Part C budget amounts; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
19 **reviewed the FY 2022 DHHS Division of Senior Services Title VI Part A and Title VI**  
20 **Part C Budget Amendments No. 1 and recommend their approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2022 Department of Health and Human Services Division of Senior Services**  
23 **Title VI Part A and Title VI Part C Budget Amendments No. 1 effective April 1, 2021**  
24 **through March 31, 2022, which will not change the Title VI Part A Budget amount**  
25 **of \$186,930.00 or the Title VI Part C Budget amount of \$68,680.00.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation chairperson or any designated official is authorized to administer and**  
28 **expend the FY 2022 Department of Health and Human Services Division of Senior**  
29 **Services Title VI Part A and Title VI Part C Budgets as amended, provided that any**  
30 **amendments or modifications shall be submitted for prior approval by the**  
31 **Tohono O'odham Legislative Council.**
