

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of Community
Health Services Public Health Emergency Preparedness Budget Amendment No. 1)**

RESOLUTION NO. 21-414

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Department of Health and Human Services Division of Community**
8 **Health Services Public Health Emergency Preparedness Budget in the amount of**
9 **\$80,000.00 was approved by Resolution No. 21-189 for the period July 1, 2021**
10 **through June 30, 2022; and**

11 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
12 **review and approval its FY 2022 Division of Community Health Services Public**
13 **Health Emergency Preparedness Budget Amendment No. 1, which is**
14 **incorporated by this reference and which will adjust personnel and/or**
15 **operational line-items; and**

16 **WHEREAS, the FY 2022 Department of Health and Human Services Division of Community**
17 **Health Services Public Health Emergency Preparedness Budget Amendment No.**
18 **1 will provide for COLA adjustments for all personnel effective October 1, 2021**
19 **through June 30, 2022 and will not change the budget amount of \$80,000.00; and**

20 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
21 **reviewed the FY 2022 Department of Health and Human Services Division of**
22 **Community Health Services Public Health Emergency Preparedness Budget**
23 **Amendment No. 1 and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **FY 2022 Department of Health and Human Services Division of Community Health**
26 **Services Public Health Emergency Preparedness Budget Amendment No. 1 in the**
27 **amount of \$80,000.00, which shall be funded by the Arizona Department of Health**
28 **Services.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation chairperson or any designated official is authorized to administer and**
31 **expend the FY 2022 Department of Health and Human Services Division of**
32 **Community Health Services Public Health Emergency Preparedness Budget**

Amendment No. 1, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.


