

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of November 2021)**

RESOLUTION NO. 21-417

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6 Ordinance No. 05-81 as amended the Enrollment Committee has received a
7 written statement from 01 tribal members who have expressed their intent to
8 relinquish their membership with the Tohono O'odham Nation and the members
9 are identified in the November 2021 Relinquishment List, which is incorporated
10 by this reference; and

11 **WHEREAS,** pursuant to Article IX Section 1 of the Enrollment Ordinance,

12 A member of the Nation may relinquish his membership in the Nation by
13 submitting a written statement clearly expressing an intent to relinquish
14 his membership to the Council, a copy of which must be served on the
15 committee. The written statement must be signed by the person wishing
16 to relinquish his membership or, if a minor or incompetent, by the
17 parent(s), guardian or other person legally authorized to act on his
18 behalf. Relinquishment does not require the approval of the Council, but
19 is effective upon receipt of the statement by the Council and cannot be
20 subsequently denied. Upon recognition by the Council that the individual
21 has renounced his membership, his name shall be deleted from the
22 membership roll.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby
24 recognizes that the one individual identified in the November 2021
25 Relinquishment List have relinquished their membership in the Tohono
26 O'odham Nation and orders the removal of their names from the Nation's
27 membership roll.

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
29 **day of NOVEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
31 **Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**


