

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**08-100, and 18-406 to Correct Names of Enrolled Members)**

**RESOLUTION NO. 21-419**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the  
6 Enrollment Committee shall review membership applications and make a  
7 written recommendation to the Tohono O'odham Legislative Council to approve  
8 or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment  
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11 O'odham Legislative Council shall determine eligibility for membership or  
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving  
14 membership and adoption applications misspelled or incorrectly listed the  
15 names of members; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 114-80, 910-85, 373-  
17 90, 95-366, 97-105, 03-003, 03-301, 04-109, 04-212, 04-659, 05-301, 05-472, 05 607,  
18 07-075, 07-236, 07-657, 08-100, and 18-406 be amended to reflect the correct  
19 names for the members identified in the November 2021 Corrected Enrollment  
20 Resolution Summary, which is incorporated by this reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22 Nos. 114-80, 910-85, 373-90, 95-366, 97-105, 03-003, 03-301, 04-109, 04-212, 04-659,  
23 05-301, 05-472, 05-607, 07-075, 07-236, 07-657, 08-100, and 18-406 are amended  
24 upon the effective date of those resolutions to reflect the correct names of  
25 members identified in the November 2021 Corrected Enrollment Resolution  
26 Summary.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
28 **day of NOVEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**  
30 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
31 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
33 **16 of the Act of June 18, 1934 (48 Stat.984).**
