RESOLUTION NO. 21-426

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power "to manage any
2		funds within the exclusive control of the Tohono O'odham Nation, including
3		proceeds derived from lands and resources of the Tohono O'odham Nation, and
4		to appropriate these funds for the benefit of the nation and its members."
5		(Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and
6	WHEREAS,	the Legislative Council has adopted and codified the Gaming Revenue
7		Distribution Formula and District Allocation Guidelines as 26 Tohono O'odham
8		Code Chapter 1, Article 3; and
9	WHEREAS,	the Formula and Guidelines were "established for purposes of allocating all
10		revenue from Gaming Facilities paid to the Nation by the Gaming Enterprise
11		pursuant to Section 7(e) of the Gaming Enterprise Charter (hereinafter referred
12		to as 'Gaming Revenues')," and the Formula allocates percentages of Gaming
13		Revenues to long-term investments (the "Desert Diamond Savings Account"), to
14		the Nation, and to district governments (26 Tohono O'odham Code Chapter 1,
15		Article 3, Section 1301); and
16	WHEREAS,	on March 2, 2020 and by Resolution No. 20-069, the Legislative Council enacted 26
17		Tohono O'odham Code Chapter 3 - Permanent Trust Fund "to establish a true
18		permanent savings fund and permanent stream of investment income to defray
19		the cost of Tohono O'odham government services provided to the O'odham
20		people," which became effective March 5, 2020; and
21	WHEREAS,	pursuant to Section 3103(A)(1) of the Permanent Trust Fund law, a portion of
22		Gaming Revenues shall be allocated to the Permanent Trust Fund as provided by
23		26 T.O.C. Chapter 1, Article 3, Section 1301, effective October 1, 2020; and
24	WHEREAS,	the Gaming Revenue Distribution Formula has not yet been updated to reflect the
25		allocation to the Permanent Trust Fund as enacted in Resolution No. 20-069; and
26	WHEREAS,	the Investment Committee and Budget and Finance Committee recommend
27		amending Section 1301 of 26 Tohono O'odham Code Chapter 1, Article 3 to reflect
28		the allocation to the Permanent Trust Fund, in accordance with the November
29		2021 Amendments, which are incorporated by this reference.
30	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council adopts the
31		November 2021 Amendments to Section 1301 of 26 Tohono O'odham Code
