

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of Senior Services
Title III B-1 Transportation and C-1 Congregate Meals Budgets Amendments No. 2)

RESOLUTION NO. 21-434

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services ("DHHS") Division of
8 Senior Services Title III B-1 Transportation Budget in the amount of \$16,000.00
9 and the C-1 Congregate Meals Budget in the amount of \$48,283.00 were approved
10 by Resolution No. 21-201 and subsequently amended by Resolution No. 21-403
11 with no change to the budget amounts; and

12 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2022
13 Division of Senior Services Title III B-1 Transportation and C-1 Congregate Meals
14 Budgets Amendments No. 2, which are incorporated by these references and
15 which will adjust operational and/or personnel line items; and

16 **WHEREAS,** the FY 2022 DHHS Division of Senior Services Title III B-1 Transportation Budget
17 Amendment No. 2 will increase the Title III B-1 Transportation Budget by
18 \$1,306.00 from \$16,000.00 to \$17,306.00; and

19 **WHEREAS,** the FY 2022 DHHS Division of Senior Services Title III C-1 Congregate Meals
20 Budget Amendment No. 2 will decrease the Title III C-1 Congregate Meals Budget
21 by \$2,807.00 from \$48,283.00 to \$45,476.00; and

22 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
23 reviewed the FY 2022 DHHS Division of Senior Services Title III B-1 Transportation
24 and C-1 Congregate Meals Budgets Amendments No. 2 and recommend their
25 approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2022 Department of Health and Human Services Division of Senior Services
28 Title III budgets amendments effective July 1, 2021:

- 29 (1) Title III B-1 Transportation Budget Amendment No. 2, which includes a

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH day of NOVEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
