

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of Senior Services Title III C-2 Home Delivered Meals Budget Amendment No. 1)

RESOLUTION NO. 21-435

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services ("DHHS") Division of
8 Senior Services Title III C-2 Home Delivered Meals Budget in the amount of
9 \$43,000.00 was approved by Resolution No. 21-201; and

10 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2022
11 Division of Senior Services Title III C-2 Home Delivered Meals Budget Amendment
12 No. 1, which is incorporated by this reference and which will adjust operational
13 line and/or personnel items; and

14 **WHEREAS,** the FY 2022 DHHS Division of Senior Services Title III C-2 Home Delivered Meals
15 Budget Amendment No. 1 will decrease the Title III C-2 Home Delivered Meals
16 Budget by \$1,940.00 from \$43,000.00 to \$41,060.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2022 DHHS Division of Senior Services Title III C-2 Home
19 Delivered Meals Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2022 Department of Health and Human Services Division of Senior Services
22 Title III C-2 Home Delivered Meals Budget Amendment No. 1 effective July 1, 2021,
23 which includes a \$1,940.00 decrease from \$43,000.00 to \$41,060.00.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2022 Department of Health and Human Services Division of Senior
27 Services Title III C-2 Home Delivered Meals Budget as amended, provided that
28 any amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.
