9		government enterprise that is responsible for operating the Nation's gaming
10		facilities and conducting gaming activities (Charter of the Gaming Enterprise
11		("Charter"), as amended, 16 Tohono O'odham Code Chapter 2); and
12	WHEREAS,	the Commerce Committee recommends amending Section 6(m)(1) and (2) of the
13	WILKEAS,	Gaming Enterprise Charter to establish a first preference for enrolled members
14		of the Tohono O'odham Nation in employment and contracting and make other
15		amendments (collectively, the "November 2021 Gaming Enterprise Charter
16		Amendments"); and
17	WHEREAS,	the Commerce Committee recommends approving the November 2021 Gaming
