

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 20-348, "Approving FY 2021 Executive Branch Vehicle
Replacement Program Budget" to Extend the Budget Authority into FY 2022)**

RESOLUTION NO. 21-440

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Executive Branch Vehicle Replacement Program Budget in the
8 amount of \$4,872,698.51 was approved by Resolution No. 19-165 and authorized
9 "that any remaining unexpended funds shall be carried forward to complete the
10 vehicle replacement program"; and

11 **WHEREAS,** the FY 2021 Executive Branch Vehicle Replacement Program Budget Amendment
12 No. 1 was approved by Resolution 20-348 which increased the budget by
13 \$175,254.00 from \$4,872,698.51 to \$5,047,952.51; and

14 **WHEREAS,** the budget authority under Resolution No. 20-348 expired on September 30, 2021,
15 which makes it necessary to extend the budget authority to September 30, 2022 to
16 expend available funds; and

17 **WHEREAS,** the Budget and Finance Committee has reviewed this resolution and recommend
18 its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends
20 Resolution No. 20-348 to extend the budget authority for the FY 2021 Executive
21 Branch Vehicle Replacement Program Budget to September 30, 2022 and that any
22 remaining unexpended funds shall be carried forward to complete the vehicle
23 replacement program.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2021 Executive Branch Vehicle Replacement Program Budget for
27 the period of October 1, 2021 through September 30, 2022, and the Accounting
28 Department is authorized to post the unexpended balances of the budget as of
29 September 30, 2021 as a carry forward in FY 2022 beginning October 1, 2021
30 provided, that any amendments or modifications shall be submitted for prior
31 approval by the Tohono O'odham Legislative Council.






