

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 San Xavier District Budget Amendment No. 1)**

RESOLUTION NO. 21-441

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2022 San Xavier District Budget in the amount of \$9,131,576.97 was
13 authorized by San Xavier District Council Resolution No. SXDC 09-21-04 and
14 approved by Legislative Council Resolution No. 21-375; and

15 **WHEREAS,** the San Xavier District applied for and received grant funds from the Tohono
16 O'odham Nation's FY 2021 Coronavirus Aid, Relief and Economic Security Act
17 ("CARES Act") Fund in the amount of \$1,277,292.11 to fund COVID-19 matters
18 affecting the San Xavier District Community; and

19 **WHEREAS,** there is a remaining balance of the FY 2021 CARES Act fund in the amount of
20 \$381,957.13 and the San Xavier District intends to expend this amount; and

21 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 11-21-06, the San Xavier
22 District has authorized and submitted for review and approval its FY 2022 San
23 Xavier District Budget Amendment No. 1, which is incorporated by this reference
24 and which will adjust operational and/or personnel line items and create a new
25 line item; and

26 **WHEREAS,** the FY 2022 San Xavier District Budget Amendment No. 1 will increase the FY 2022
27 San Xavier District Budget by \$381,957.13 from \$9,131,576.97 to \$9,513,534.10 by
28 incorporating the remaining balance of FY 2021 CARES Act grant funds; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 San Xavier District
30 Budget Amendment No. 1 and recommends its approval.



1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
2 FY 2022 San Xavier District Budget Amendment No. 1, which includes a
3 \$381,957.13 increase from \$9,131,576.97 to \$9,513,534.10, which will adjust
4 operational and/or personnel line items and create a new line item, that shall be
5 funded by the remaining FY 2021 Tohono O'odham Nation CARES Act grant funds.

6 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 San
7 Xavier District Budget as amended shall be managed and expended in
8 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
9 Nation and the Nation's laws, provided that any amendments or modifications
10 shall be authorized under a District Council resolution and submitted for prior
11 approval by the Tohono O'odham Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH
13 day of NOVEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,001.4 FOR;
14 -0- AGAINST; -0- NOT VOTING; and 216.6[03] ABSENT, pursuant to the powers vested in the
15 Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by
16 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat.984).




